

Moreover, he was Visiting Fellow at Canberra University, Australia. His current areas of research are: intercultural communication and management, "inclusive" culture and management in transnational organizations, communication and HRM in complex organizational systems, theory of flexible and post-bureaucratic organizations, new sustainable forms of organizations, new forms and models of organizational change. He is also a Management Consultant and Trainer. He collaborates with Italian and multinational private and public companies, as Advisor and Management Consultant and Trainer, supporting Top Management, HRM, and Internal Communication Functions in the planning and implementation of strategies and projects and in the design and delivery of learning activities.
